  - 4.1 <u>Five (5) trading days before</u> and two (2) trading days after the disclosure of defined periodic reportorial requirements required by the Securities and Exchange Commission (SEC), Philippine Stock Exchange (PSE) and the Philippine Dealing Exchange Corporation (PDEX). The Blackout Period applies regardless of the issuance or receipt of the Blackout Period reminder notice.

4.2 Two (2) trading days after the disclosure of any material information other than Item 4.1 above. The Corporate Secretary shall issue an Office Bulletin to affected individuals for Special Blackout Periods that mat be imposed from time to time.
